- 1) Permit applications require floor plans and elevation drawings of new structures, a site plan showing the location of existing and new structures, septic tank and field, well, and measurements to the road, all property lines, well and septic field.
- 2) The construction, alteration, renovation or installation of chimneys must be in accordance with NFPA 211
- 3) The construction, alteration, renovation or installation of stairways, handrails, guardrails, smoke detectors, fire escapes or means of egress from buildings must be in accordance with NFPA 101
- 4) NFPA's referenced in 2 & 3 must be the version most currently adopted by the State of Maine's Fire Marshal's Office at the time of permit approval.
- 5) Inspection of buildings during construction or alteration is at the Code Enforcement Officers discretion.
- 6) All new buildings are required to have a manual external electrical shut-off device installed during construction.

OWNER / APPLICANT STATEMENT

I give my consent for the Code Enforcement Officer to enter and inspect the project during normal business hours.
